**RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS** (this "Release") is made as of April [6], 2012 ("Effective Date") by JPMorgan Chase Bank, N.A. (fka Bank One, Texas, NA and Bank One, NA), as collateral agent (the "Collateral Agent") for the benefit of The Container Store, Inc. (the "Grantor"). Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Security Agreements.

**WHEREAS**, pursuant to the terms and conditions of (i) that certain Intellectual Property Security Agreement, dated as of August 16, 2007 (the "Term Facility Intellectual Property Security Agreement"), (ii) that certain Intellectual Property Security Agreement, dated as of August 16, 2007 (the "ABL Facility Intellectual Property Security Agreement"), (iii) that certain Security Interest Assignment of Trademarks, dated as of September 11, 2000, and (iv) that certain Second Amended and Restated Pledge and Security Agreement, dated as of June 30, 2004 (collectively, the "Intellectual Property Security Agreements"), Grantor pledged, assigned and granted to the Collateral Agent a continuing security interest in and lien on and right of set-off against all of its right, title and interest in and to its IP Collateral (as defined herein), including without limitation the trademark registrations and applications set forth on Schedule A hereto and the goodwill associated therewith (collectively, the "Trademark Collateral") and the patent registrations and applications set forth on Schedule B hereto (collectively, the "Patent Collateral") and together with the Trademark Collateral, the "IP Collateral");

**WHEREAS**, the Intellectual Property Security Agreements were recorded with the United States Patent and Trademark Office ("PTO"), (i) with respect to the Trademark Collateral, on (a) April 2, 2001 at Reel 2270, Frame 0555, (b) December 23, 2004 at Reel 3102, Frame 0803, (c) August 21, 2007 at Reel 3605, Frame 0804 and (d) August 22, 2007 at Reel 3606, Frame 0458 and (ii) with respect to the Patent Collateral, on (x) August 21, 2007 at Reel 019724, Frame 0258 and (y) August 22, 2007 at Reel 019729, Frame 0837.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby terminates the Intellectual Property Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the IP Collateral.

If and to the extent Collateral Agent has acquired any right, title or interest to any of the IP Collateral, it hereby assigns and transfers such rights, title or interest to Grantors.

Collateral Agent shall take all further actions, reasonably acceptable to Collateral Agent, and provide to Grantors and each of their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments),

requested by Grantors, each at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.




