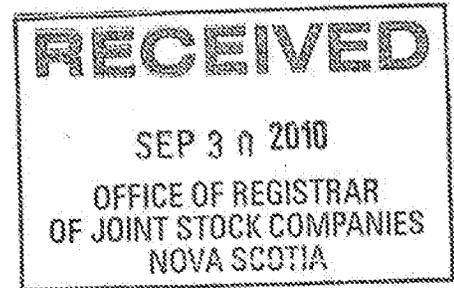

SPECIAL RESOLUTION

**CONTINUANCE OF THE CORPORATION
UNDER THE LAWS OF NOVA SCOTIA**



WHEREAS the Corporation was incorporated pursuant to the *Business Corporations Act* (Ontario) (the "OBCA") by articles of amalgamation dated August 12, 1998; and

WHEREAS it is proposed to continue the Corporation under the *Companies Act* (Nova Scotia) (the "*Companies Act*");

RESOLVED as a special resolution that:

1. the Corporation file an Application for Authorization to Continue in Another Jurisdiction in the form prescribed by the OBCA with the Director appointed to carry out the duties and exercise the powers of that office under the OBCA so that it may proceed with the filing of an application to continue the Corporation under the *Companies Act*;
2. the Corporation is authorized to apply to the Registrar of Joint Stock Companies of Nova Scotia pursuant to Section 133 of the *Companies Act* for a Certificate of Continuance to continue as an unlimited company if it had been incorporated as an unlimited company under the laws of the Province of Nova Scotia;
3. subject to the issuance of a Certificate of Continuance and without affecting the validity and existence of the Corporation by or under its articles and the validity of any act done thereunder, the Corporation hereby approves and adopts the Memorandum of Association in the form attached hereto as Schedule "A" and the Articles of Association in the form attached hereto as Schedule "B";
4. subject to such continuance and without affecting the validity of the Corporation by or under its articles and of any act done thereunder, its articles are hereby amended to make all changes contemplated by such Memorandum of Association and such Articles of Association and to conform to the *Companies Act*, including the change of name of the Corporation to *ExtendMedia ULC*, such changes to become effective upon obtaining the approval of the Registrar of Joint Stock Companies of Nova Scotia;
5. any officer or director of the Corporation is authorized to do all acts and to execute (whether under the corporate seal of the Corporation or otherwise) and deliver all documents or instruments which may be necessary or desirable in order to give effect to the foregoing including, without limitation, the execution and filing of the Application for Authorization to Continue in Another Jurisdiction in the form required pursuant to the OBCA and the execution and filing of all documents and forms required pursuant to the *Companies Act*; and

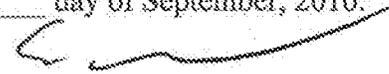
