**DEED OF CONFIRMATION OF ASSIGNMENT**

**BETWEEN:**

1. **THE ABSOLUT COMPANY AB**, (formerly known as V&S Vin & Sprit AB) a company incorporated in Sweden (registered number 556015-0178) and whose registered office is SE-117 97 Stockholm, Sweden (the "Assignor") and
2. **CHIVAS HOLDINGS (IP) LIMITED** a company incorporated in Scotland (registered number SC331555) and whose registered office is at 111/113 Renfrew Road, Paisley, PA3 4DY, Scotland (the "Assignee");

hereinafter together referred to as "**the Parties**".

**WHEREAS**

1. The Parties have entered into the Assignment (as defined below).
2. The Parties have agreed to enter into this deed to confirm that the Trademarks (as defined below) were assigned by the Assignor to the Assignee pursuant to the Assignment.

**NOW THEREFORE THE PARTIES HERETO AGREE AS FOLLOWS:-**

**1. Definitions and Interpretation**

---

Unless the context otherwise provides, the words and expressions used in this deed shall have the following meanings:

"Assignment"	means an Intellectual Property Assignment entered into between the Parties on 30 March 2012;
"Schedules"	means the schedule which is annexed to and forms part of this deed; and
"Trademarks"	means the registered trademarks set out in Part A of the Schedule

**1. Confirmation**

---

The Parties confirm, acknowledge and agree that pursuant to the Assignment and with effect from 30 March 2012, the Assignor as legal owner:

- (a) assigned and transferred to Assignee, the whole right, title and interest past, present and future in and to the Trademarks in Part A for the full period during which such rights subsist including any and all goodwill attached to the Trademarks; and

- (b) assigned to Assignee, the rights, powers, privileges and immunities conferred on the proprietor of the Trademarks and the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action arising from ownership, of any of the Trademarks whether occurring before, on or after the date of the Assignment.
- (c) The Assignment was for good and valuable consideration which consideration is hereby acknowledged by both parties.

**2. Governing Law and Jurisdiction**

---

This deed, its interpretation and any disputes under or in connection with it, will be governed by and construed in accordance with the laws of England and Wales and will be subject to the exclusive jurisdiction of the English courts.


**3. Counterparts**


