**IP TRANSFER DEED**

---

**BETWEEN:**

(1) **Telex Communications (UK) Limited**, incorporated and registered in England and Wales with company number 2412018 whose registered office is at Klark Industrial Park, Walter Nash Road, Kidderminster, West Midlands DY117HJ;

(2) **Telex Communications, Inc.**, a Delaware corporation (SEC CIK 857668) having offices located at 12000 Portland Ave South Burnsville, MN 55337, USA;

(3) **EVI Audio GmbH**, incorporated and registered in Germany with company number Amstgericht Straubing HRB 10387 whose registered office is at Sachsenring 60 D-94315 Straubing, Germany;

(4) **Robert Bosch GmbH**, incorporated and registered in Germany with company number Amstgericht Stuttgart HRB 14000 whose registered office is at Robert-Bosch-Platz 1, D-70839 Gerlingen, Germany;

(5) **EVI Audio Japan Limited**, incorporated and registered in Japan with company number 0110-01-062366, whose registered office is at 5-3-8 Funabashi, Setagaya-Ku Tokyo, Japan;

(6) **Bosch Security Systems, Inc.**, a Delaware corporation with company number 3717960 having offices located at 130 Perinton Parkway Fairport, NY 14450, USA

(known singularly as a Transferor and collectively as the Transferors); and

(7) **Red Chip Company Ltd**, incorporated and registered in the British Virgin Islands with company number 241452 whose registered office is at Trident Chambers, Wickhams Cay, P.O. Box 146, Road Town, Tortola, British Virgin Islands (the Transferee).

The parties agree as follows:

**PREAMBLE**

- (A) Telex Communications (UK) Limited and Midas Klark Teknik Limited (the Buyer) entered into an Asset Purchase Agreement on 8 December 2009 under which the Buyer purchased a part of the business of Telex Communications (UK) Limited (the "APA").
- (B) Under the APA, the Buyer has, as part of the Business, purchased certain intellectual property rights.
- (C) The Transferee is the intellectual property holding company within the Buyer's group.
- (D) By this IP Transfer Deed, the Transferors assign to the Transferee the intellectual property rights as set out in this Deed.

**1. DEFINITIONS**

In this Deed, capitalised terms and abbreviations shall have the meaning set forth below. Unless otherwise indicated, the definition of a term in the singular shall include the definition of such term in the plural and *vice versa*.

- 1.1 "Buyer Group" shall have the meaning as defined in the APA;

- 1.2 "Deed" shall mean this IP Transfer Deed;
- 1.3 "APA" shall have the meaning as defined in Section (A) of the Preamble;
- 1.3 "Business" shall have the meaning as defined in the APA;
- 1.4 "Completion Date" shall have the meaning as defined in the APA;
- 1.5 "Exclusively Used IP" is as defined at clause 5;
- 1.6 "Intellectual Property Rights" means patents, rights to inventions, copyright and related rights, trade marks, trade names, registered and unregistered design rights, and domain names, rights to goodwill or to sue for passing off, rights in designs, rights in computer software, database rights, rights in confidential information (including know-how), rights in commercial information and technical information, research and development data, manufacturing methods and data, specifications and drawings, formulae, algorithms and prototypes and any other intellectual property rights, in each case whether registered or unregistered and including all applications (or rights to apply) for, and renewals or extensions of, such rights and all similar or equivalent rights or forms of protection which subsist at Completion Date in any part of the world;
- 1.7 "Legal Terms" shall have the meaning as defined in clause 2.2.6;
- 1.8 "Robert Bosch Group" shall mean Robert Bosch GmbH incorporated and registered in Germany Amtsgericht Stuttgart HRB 14000, whose registered office is at Robert Bosch Platz, D 70839 Gerlingen and all affiliated companies controlled by Robert Bosch GmbH;
- 1.9 "Transferred IP" shall mean Transferred Patents, Transferred Trademarks, Transferred Domain Names, and the Exclusively Used IP;
- 1.10 "Transferred Patents" shall mean the patents and patent applications listed at Schedule 1;
- 1.11 "Transferred Trademarks" shall mean the trademarks and trademark applications listed in Schedule 2; and
- 1.12 "Transferred Domain Names" shall mean the domains listed in Schedule 3.

## 2. INTERPRETATION

### 2.1 Table of contents, headings, sub-headings

The table of contents, headings and sub-headings are for convenience purposes only and shall not affect the interpretation of this Deed.

### 2.2 Certain references

Unless otherwise expressly set forth in this Deed, a reference to:

- 2.2.1 a "Clause" or "Schedule" is a reference to a section or schedule of this Deed, unless the context states otherwise;
- 2.2.2 a "disposal" means a sale, assignment, transfer, lease, license, trust arrangement or other disposal, whether by means of a single transaction or a series of transactions, and "dispose" is construed accordingly;

- 2.2.3 the words "hereby", "herein", "hereof" or "hereunder" is a reference to this Deed in whole and not a specific provision of this Deed;
- 2.2.4 the words "including", "includes", "in particular" or "such as" shall be deemed to be followed by the phrase "without limitation" and shall not be construed to express limitation in any way;
- 2.2.5 any reference to the Transferors shall mean the relevant Transferors of the rights in the Transferred Patents, Transferred Domain Names, Transferred Trademarks, and/or Exclusively Owned IP, each with respect to the respective rights they own, respectively, in the case of Transferred Domain Names, are registered with;
- 2.2.6 any types of legal entities, participations, proceedings, courts, arbitrators, governmental authorities, laws, regulations, rights or legal relationships (together the "Legal Terms") includes a reference to any corresponding or identical Legal Terms under foreign law and, where no corresponding or identical Legal Terms exist under foreign law, it includes a reference to such Legal Terms under foreign law which come functionally closest to the relevant Legal Terms under English law.

### **3. PROVISIONS PERTAINING TO THE TRANSFERRED PATENTS AND TRANSFERRED TRADEMARKS**

#### **3.1 Transfer of the Transferred Patents and Transferred Trademarks**

The Transferors hereby assign with full title guarantee to the Transferee and with effect from the Completion Date the Transferred Patents and the Transferred Trademarks and all rights in and to the Transferred Patents and the Transferred Trademarks, together with the goodwill vesting in those Transferred Patents and Transferred Trademarks (as attached to them as was generated prior to Completion Date), and the benefit of the applications for registration of the above with the intention that, when the applications are granted, the registrations shall vest in the Transferee. The Transferee hereby accepts the transfer.

In respect of the Transferred Patents, the Transferors also assign to the Transferee the right to apply for, prosecute and obtain patent protection in any country for an invention embodied by any of the applications comprised in the Transferred Patents, or the Exclusively Used IP including the right to claim priority from such applications.

In the event that the Transferee has given written notice prior to Completion Date to the Transferors that with respect to a particular Transferred Trademark another entity of the Buyer Group is to be the Transferee (the "Entity"), then for that particular Transferred Trademark only the Entity shall have the rights and obligations of the Transferee under the terms of this Deed, and the Transferee shall ensure that all rights, obligations and restrictions as set out in this Deed shall be enjoyed, complied with and respected by the Entity, with respect to the relevant Transferred Trademark, and the Transferee shall hold the Transferors harmless from any claims or actions on the part of the Entity with respect to the relevant Transferred Trademark to which it would not have been entitled had the Entity signed this Deed as a party.

#### **3.2 Proceedings**

The assignment of the Transferred IP shall include the right for the Transferee to bring proceedings in respect of any part of the Transferred IP against any third party for

infringement, passing off or otherwise infringing the rights of the Transferors in the Transferred IP where such infringement occurred prior to the date of this Deed.

The Transferors also shall, without undue delay after they are asked to do so in writing by Transferee, duly complete all the forms necessary and -- provided that Transferee pursues its registration as new holder of the Transferred Trademarks/Transferred Patents without undue delay -- to support the Transferee with all needed declarations necessary on the Transferors' part to enforce them against third parties who infringe them, or, (in case of trademarks) who apply for trademarks which are confusingly similar to the Transferred Trademarks as listed in Schedule 2. This support will be granted for the period until the Transferee has been registered as holder of the respective intellectual property right in the registers of the respective competent offices, however, Transferors are prepared on request and at the expense of Transferee, for a period of two (2) years of Completion Date, to provide additional documents available at Transferors to support Transferee for the abovementioned purposes, to the extent this does not jeopardize Transferors' operations or conflicts either with confidentiality rules or overriding business interests.

### **3.3 Registration of the Transferred Patents and the Transferred Trademarks; assistance**

The Transferee may, at any time and at its sole discretion, record the assignment of the Transferred Patents and the Transferred Trademarks in the registers of the respective competent offices. The Transferors shall, without undue delay after they are asked to do so in writing by the Transferee, duly complete all the forms and execute such documents and/or deeds and carry out all the other acts necessary for such registration in this regard, in particular issuing declarations. Any costs (excluding the internal costs of the Transferors) for such registration of the Transferred Patents and Transferred Trademarks shall be borne by the Transferee.

### **3.4 Surrender of documents; further maintenance; costs**

3.4.1 The Transferors shall, within 30 (thirty) days after the Completion Date, surrender to the Transferee the following documents relating to the Transferred Patents and Transferred Trademarks, each of them if and to the extent they actually are in the Transferors' possession or held by third parties on behalf of a Transferor: (i) copies of all documents submitted to and received from patent and other registration offices during the prosecution process, (ii) copies of any material correspondence with third parties with regard to the prosecution of the Transferred Patents and the Transferred Trademarks, and (iii) if applicable, the original granting certificates for these rights.

3.4.2 The Transferee shall be responsible for maintenance and prosecution of Transferred Patents and Transferred Trademarks (e.g. paying of annuities becoming due after the Completion Date, duly answering official notices, etc.) as of the Completion Date, if not otherwise agreed upon for specific cases in writing between the Transferors and the Transferee. The Transferors have done all actions and paid all monies due in respect of the maintenance of the Transferred Patents and the Transferred Trademarks up to the Completion Date.

3.4.3 Should the Transferors, after the Completion Date but prior to the registration of a Transferred Patent/Transferred Trademark in the name of Transferee, pay any reasonable costs in connection with the maintenance or prosecution of the Transferred Patents and Transferred Trademarks for the period after the Completion Date (although not being obliged to do so, see Section 3.4.2), the Transferors shall inform Transferee thereof in advance, and provide the Transferee



with written evidence of the payment of such costs together with reasons for their payment. The Transferee will reimburse the Transferors for such reasonable undisputed costs incurred by the Transferors in the further maintenance or prosecution of the Transferred Patents and Transferred Trademarks within 30 (thirty) days after receipt of an invoice (accompanied by evidence that such payments have been made) into a bank account specified by a Transferor from time to time. In case of default with payments, the Transferee shall bear interests in the amount of 1% (one percent) per month of default.

#### **4. PROVISIONS PERTAINING TO THE TRANSFERRED DOMAIN NAMES**

##### **4.1 Transfer**

The Transferors hereby agree to the registration of the Transferred Domain Names in the name of the Transferee in the respective domain registers of the respective registrars. Should, under applicable provisions in a certain country, registration in the name of the Transferee not be possible, or if the Transferee prefers that the Transferred Domain Names be held in the name of another entity of the Buyer Group the Transferors shall, upon written request of the Transferee, register the relevant Transferred Domain Names in the name of a third party or entity of the Buyer Group as identified to the Transferors prior to the Completion Date in writing by the Transferee.

The Transferors shall, as soon as requested to do so in writing by the Transferee (and/or its designee), duly complete all the forms and execute all documents and/or deeds necessary for the registration and the acquisition of full and unrestricted technical control over the Transferred Domain Names, and shall carry out all the other acts necessary in this regard, in particular issuing declarations.

As far as Transferred Domain Names are held by an individual (Mr. Godbehear), the agreement declaration to register such Transferred Domain Names for Transferee is attached as Schedule 4 to this Deed. Transferor (1) shall, as long as the said individual is employed by it, do all such things as are necessary and use its best endeavours to cause such individual to sign said declaration.

##### **4.2 Surrender of documents**

The Transferors shall, within 30 (thirty) days, surrender to the Transferee copies of any material correspondence with third parties (including the relevant providers) with regard to the Transferred Domain Names.

#### **5. EXCLUSIVELY USED INTELLECTUAL PROPERTY RIGHTS**

The Transferors hereby assign with full title guarantee to the Transferee absolutely and with effect from the Completion Date any and all other Intellectual Property Rights (aside from the Transferred Patents, Transferred Trademarks and Transferred Domain Names) which are used exclusively in the Business as at the Completion Date ("Exclusively Used IP").

The Transferors shall execute and sign all instruments, applications and documents and do all such acts and things as may reasonably be required by the Transferee to enable the Transferee to enjoy the full benefit of the rights granted to it in respect of the Exclusively Used IP.

**6. LICENSE UNDER INTELLECTUAL PROPERTY RIGHTS USED BY THE BUSINESS**

6.1 To the extent the Transferors and Robert Bosch Group own Intellectual Property Rights (other than trade marks and trade names) which are used, but not exclusively used, in the Business as of the Completion Date, the Transferors hereby grant to the Transferee, also (on behalf of the Transferors and Robert Bosch Group), a non-exclusive, royalty free, perpetual, non-sublicenseable (subject to clause 6.2) and non-transferrable (subject to clauses 6.2 and 6.3), license to use, or have used by the Buyer such Intellectual Property Rights in the Business as it is conducted as of the Completion Date. This license includes the use of Intellectual Property Rights used by the Business at Completion Date also in the manufacture and sale of modified products, within the same product range as those in production at Completion Date.

6.2 The Transferors agree that, if the Buyer assigns all or parts of the Business to a member(s) of the Buyer Group, then the Transferee may transfer or sub-license the license, as it is set out in clause 6.1 and as far as applicable to the part of the Business assigned, as well as those restrictions on liability, as set out in clause 7 to the extent related to such license, to such member of the Buyer Group along with, and for application in, such assigned Business.

6.3 If the Buyer transfers all or substantially all of the Business to a third party, the license, as set out in clause 6.1, as well as those restrictions on liability, as set out in clause 7 to the extent related to such license, shall, to the extent used by the Business at the time of such transfer, be transferable to the purchaser of such Business, for further use in such Business only, always provided that in case the license is thus transferred, the Buyer shall inform the Transferors within one (1) month after the closing of the respective transaction of the identity of the purchaser of the Business.

**7. LIABILITY**

7.1.1 It is clarified that the Transferors' warranty and liability regarding the Transferred Patents, the Transferred Trademarks the Transferred Domain Names the Intellectual Property Rights licensed pursuant to clause 6, and the Exclusively Used IP, in particular with respect to correctness, completeness, technical usability, validity and freedom of third party rights, is exclusively set forth in the APA and that this Deed thus does neither establish, nor restrict any warranty or liability of the Transferors not expressly set forth in the APA or exceeding the warranty and liability expressly set forth in the APA. Also, the provisions of the APA relating to any rights (such as licenses or covenants not to sue) that have been granted to third parties or any of Transferors or Robert Bosch Group shall remain unaffected.

7.1.2 Therefore, the Transferors do not, by virtue of this Deed, assume any warranty, in particular for the technical or economic success of products developed, manufactured and/or disposed of by the Transferee by use of the Transferred Patents, the Transferred Trademarks the Transferred Domain Names, the Intellectual Property Rights licensed pursuant to clause 6, and the Exclusively Used IP, nor for the processes employed in the manufacture of such products, for their freedom from proprietary rights of third parties, for their quality or for their compliance with government regulations.

8. TAXES AND LEVIES

Taxes or any other levy, in particular withholding taxes or transfer taxes, triggered by a transfer under this Deed, if any, shall be borne by the Transferee.

9. APPLICATION OF SEVERAL CLAUSES OF THE APA

Sections 31 (Notices and Communication) to 34 (Third Party Rights) of the APA shall apply *mutatis mutandis* to this Deed.

10. COUNTERPARTS

This Deed may be executed in any number of counterparts, each of which, when executed and delivered, will be an original, and all counterparts together will constitute one and the same instrument.

11. TRUST

The Transferors agree that, to the extent that any of the rights to be assigned under this Deed are not wholly and/or validly assigned, the Transferors shall hold them upon a bare trust for the full and exclusive benefit of the Transferee.

12. GOVERNING LAW

This Deed will be governed by and construed in accordance with the laws of England and Wales. Each Party irrevocably submits to the non-exclusive jurisdiction of the Courts of England and Wales over any claim or matter arising under or in connection with this Deed.

This document has been executed as a deed and is delivered and takes effect on the date stated at the beginning of it.
