DISTRIBUTION AGREEMENT

THIS DISTRIBUTION AGREEMENT (the "Agreement") is effective as of December 31, 2011, (the "Effective Date") by and between Reprographics Northwest, LLC, a California limited liability company ("Repro NW"), ARC Acquisition Corporation, a California corporation ("ARC Acquisition"), and American Reprographics Company, L.L.C., a California limited liability company ("ARC,LLC").

WHEREAS, ARC Acquisition owns 100% of the membership interest of Repro NW.

WHEREAS, ARC,LLC owns 100% of the issued and outstanding capital stock of ARC Acquisition.

WHEREAS, Repro NW desires to distribute its entire right, title and interest in and to the assets of its operating division known as the Reprographics Northwest division (the "Division") to ARC Acquisition.

WHEREAS, immediately following the above referenced transfer, ARC Acquisition desires to distribute such right, title and interest in and to the assets of the Division to ARC,LLC.

WHEREAS, Repro NW, ARC Acquisition and ARC,LLC intend for such distributions to be tax-free under Sections 721 and 118 of the Internal Revenue Code of 1986, as amended.

NOW, THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Repro NW hereby distributes its entire right, title and interest in and to the assets of the Division to ARC Acquisition.

2. Immediately following such distribution ARC Acquisition hereby distributes its entire right, title and interest in and to the assets of the Division to ARC,LLC.

3. ARC Acquisition and ARC,LLC hereby accept the distributions described in Paragraphs 1. and 2., above.

4. Miscellaneous Provisions.


(a) Amendment. This Agreement may only be amended, modified, altered, waived, suspended or supplemented by a written agreement signed by authorized representatives of the parties hereto making express reference to the provisions to be amended.

(b) Counterparts. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument and shall become a binding Agreement when one or more of the counterparts have been signed by each of the parties and delivered to the other party.

IN WITNESS WHEREOF, the parties hereto have duly executed this Agreement as of the Effective Date.


