ASSIGNMENT OF SERVICE MARKS

RECITALS:

R.1 Dominant Brands LLC is a New York limited liability company located at 28-42 210th Street, Bayside, New York 11360, (hereinafter referred to as the "Assignor").

R.2 E.F. Hutton Group, Inc. is a Wyoming corporation located at 77 Water Street, 7th Floor, New York, New York 10005 (hereinafter referred to as the "Assignee").

R.3 Assignor is the sole and exclusive owner of the United States service marks for E.F. HUTTON registered with the United States Patent and Trademark Office ("USPTO") on April 3, 2012, as reflected in U.S. Registration No. 4,122,970, together with the goodwill of the business symbolized thereby and  registered with the USPTO on April 10, 2012, as reflected in U.S. Registration No. 4,126,754, together with the goodwill of the business symbolized thereby (collectively, the "Service Marks").

R.4 Assignor desires by means of this Assignment of Service Marks to assign, convey and transfer to the Assignee all of the Assignor's rights in the Service Marks, including (i) all of the Assignor's common law service mark rights as now or previously used in connection with its business services, and (ii) all registration rights in U.S. Registration Nos. 4,122,970 and 4,126,754, together with the good will of the business associated therewith.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, said Assignor does hereby sell, assign, convey and transfer unto said Assignee all of the Assignor's right, title and interest in and to the said Service Marks and their associated federal trademark Registrations, together with the goodwill of the business symbolized by the Service Marks, the same to be held and enjoyed by Assignee for its own use, and for the term or terms for which said Service Marks have been registered as fully and entirely as the same would have been held and enjoyed by Assignor, including all rights to injunctive relief, damages or profits, due or accrued, arising out of past infringement of said Service Marks or injury to the said goodwill, and the right to sue for and recover the same in its, the Assignee's own name.
