RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, IDQ Operating, Inc. (f/k/a Interdynamics, Inc.), a New York corporation , (“Debtor”) with principal place of business at 560 White Plains Road, Tarrytown, New York 10591, granted a continuing security interest in, lien and mortgage in and to certain trademarks and related rights of Debtor, including without limitation the trademarks listed in Schedule A, to Freeport Financial LLC, a Delaware limited liability company with principal place of business at 500 West Madison, Suite 1710, Chicago, Illinois 60661, as Agent (“Secured Party”) as set forth in that certain Trademark Security Agreement, dated as of November 20, 2007, by Debtor in favor of Secured Party (the “Trademark Security Agreement”);

WHEREAS, Debtor has requested that Secured Party release its interest in the trademarks and related rights of Debtor, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

1. fully releases, discharges and extinguishes any and all liens, security interests, mortgages, right, title and interest of Secured Party granted pursuant to the Trademark Security Agreement in the trademarks and related rights of Debtor, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind; and

2. hereby assigns to Debtor any and all rights, title or interest Secured Party may have obtained pursuant to the Trademark Security Agreement in or to the trademarks and related rights of Debtor; and

3. authorizes and requests that the USPTO note and record the existence of the release hereby given.
