WHEREAS, ASSIGNOR is the exclusive and record owner of the entire right, title, and interest in and to the trademark and the corresponding United States Trademark Registration identified in Exhibit A attached hereto, together with the goodwill established by use of the Trademark;

WHEREAS, ASSIGNEE is desirous of acquiring the Trademark;

NOW THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR does hereby assign, transfer, and sell unto said ASSIGNEE the entire right, title, and interest in and to the Trademark and the associated usage and goodwill, including all rights of action against third parties for past, present and future infringement or other unauthorized use of the Trademark, the same to be held and enjoyed by said ASSIGNEE as fully and entirely as the same would have been held by ASSIGNOR had this transfer, assignment, and sale not been made.

ASSIGNOR hereby warrants and covenants that it has the full power and authority to convey the rights, title, and interest herein assigned, transferred, and sold to ASSIGNEE, that it has not executed and will not execute any agreement in conflict herewith, and that it will execute


any and all other instruments which may be necessary to perfect and evidence ASSIGNEE's ownership of the property and rights herein conveyed.

The Parties agree that this Assignment constitutes the entire agreement between ASSIGNOR and ASSIGNEE with respect to the subject matter hereof. The Parties also agree that no modification or waiver or any amendment to any provision of this Assignment shall be binding upon either party unless it is made in writing and signed by both Parties.

This Assignment may be signed in counterparts, each of which shall be deemed an original but all of which shall together constitute one instrument.

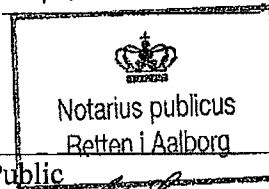


