Assignor further authorizes the Commissioner of Patents and Trademarks of the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Assignment.

Assignor further agrees to execute such further documents as may be reasonably required to record Assignee as the owner of the Trademarks and registrations and applications herein assigned, solely at the cost of Assignee.

This Assignment may be executed in any number of counterparts, any of which may be manually executed and transmitted by facsimile or electronic mail transmission, and each of which will be deemed to be an original, and all of which, when taken together, shall be deemed to constitute one and the same instrument.

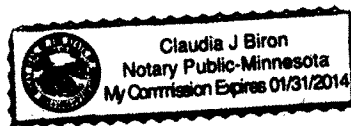
