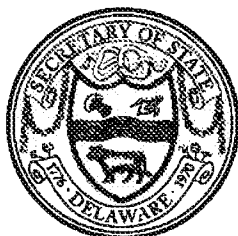

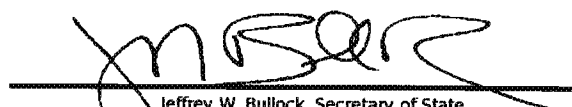

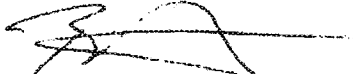
1. The name of the limited liability company is SDK Acquisition, LLC (the "Company").
