**TRADEMARK ASSIGNMENT**

WHEREAS, Consolidated Distributors Inc., a New York corporation having an address of 719 Eastern Park, Suite 3, Brooklyn, NY 11213 (hereinafter "Assignor") is the owner of certain rights in the mark "NUK" for clothing, namely shirts, (the "Mark") and United States Trademark Application Serial No. 85/129,060 for the mark "NUK" (the "Application"); and

WHEREAS, Mapa GmbH, a German Limited Liability Company having an address at Industriestrasse 21-25, D - 27404 Zeven, Germany (hereinafter the "Assignee") is desirous of acquiring any and all rights that the Assignor may have in and to the Mark and the Application, together with the goodwill of the business in connection with which the Mark is intended to be used and which is to be symbolized by the Mark, along with the right to recover for damages and profits for past infringements thereof.

NOW, THEREFORE, by good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor does hereby quitclaim and assign unto the Assignee all right, title, and interest in and to the Mark and the Application for the United States, and throughout the world together with 1) the goodwill of the business in connection with which the Mark is intended to be used and which is to be symbolized by the Mark, 2) the right to recover for damages and profits for present and future infringements thereof, and 3) the rights to sue for present and future infringements or misappropriations of the Mark.

The Assignor agrees to execute and deliver at the request of the Assignee all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all of the Assignor's rights, title, and interest in and to the Mark and the Application in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such evidence is in the possession or control of the Assignor, which shall include, without limitation, execution of any forms, statements or other documents required by any trademark office relating to the Mark or the Application. Notwithstanding the foregoing, the Assignee shall be exclusively responsible for any fees or payments to third parties arising from such efforts.
