**CERTIFICATE OF FORMATION
OF

The undersigned, acting as the sole organizer of a limited liability company formed under Section 10.155(a) of the Texas Business Organizations Code (the "**BOC**"), does hereby adopt the following Certificate of Formation for Mr. Rooter LLC (the "**Company**"):

Article 1 – Entity Name and Type

The Company formed is a limited liability company. The name of the Company is Mr. Rooter LLC.

Article 2 – Registered Agent and Registered Office

The initial registered agent is an organization by the name of:


