**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 23, 2012 (“Release”), is made by Bank of America, N.A., as Administrative Agent (the “Administrative Agent”) in favor of AARC, LLC, as successor-in-interest to AARC, Inc. (the “Grantor”).

WHEREAS, pursuant to that certain Security Agreement dated as of December 5, 2011 and its predecessors (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Obligors party thereto and the Administrative Agent, each Obligor granted to the Administrative Agent, for the ratable benefit of the holders of the Secured Obligations, a security interest in any and all right, title or interest of such Obligor in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing;

WHEREAS, pursuant to the Security Agreement, Grantor, an Obligor, executed and delivered to Administrative Agent, for the ratable benefit of the holders of the Secured Obligations, the Notices of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office (“USPTO”) on December 6, 2011 at Reel 4673 Frame 0001, September 2, 2008 at Reel 3845 Frame 0254, March 27, 2008 at Reel 3747 Frame 0346, September 7, 2004 at Reel 2930 Frame 0193, October 9, 2002 at Reel 2599 Frame 0071, and November 15, 1999 at Reel 1991 Frame 0984 (each a “Notice”, and collectively, the “Notices”).

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the holders of the Secured Obligations, and Grantor (the “parties”) agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notices.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the holders of the Secured Obligations, without representation, warranty, or recourse, hereby:


(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Trademarks, Trademark Licenses, and Proceeds of the foregoing, including the foregoing listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO.
