**RELEASE OF TRADEMARK SECURITY AGREEMENT**

WHEREAS, on May 1, 2000, COLHOC Limited Partnership ("COLHOC") entered into a Trademark Security Agreement with JPMorgan Chase Bank, N.A., as Book Manager and Administrative Agent, successor in interest to The Chase Manhattan Bank, a banking corporation organized under the laws of the State of New York ("JPMorgan") in which COLHOC granted, assigned, transferred and conveyed to JPMorgan a security interest in all right, title and interest in COLHOC's United States Trademarks and Trademark Registrations ("Trademark Collateral") to secure the payment and performance in full of all obligations under the Trademark Security Agreement;

WHEREAS, JPMorgan Chase Bank, N.A., acknowledges that COLHOC has made full payment and performance of all obligations under the Trademark Security Agreement and that the Trademark Security Agreement has terminated.

NOW, THEREFORE, JPMorgan releases the security interest in all right, title and interest in the Trademark Collateral assigned and granted by COLHOC pursuant to the May 1, 2000 Trademark Security Agreement.
