"The exact name of of the corporation is: VideoLink, Inc."

Article IV is hereby further amended by adding at the end thereof, the following:

"Effective on the date these Articles of Amendment are filed with the Secretary of the Commonwealth of Massachusetts (the "Effective Date"), each issued and outstanding share of Class B Common Stock ("Existing Class B Common Shares") shall be and hereby is automatically converted and reclassified into one (1) share of issued and outstanding Class A Common Stock ("New Class A Shares"). The Corporation shall provide certificates representing New Class A Shares to holders of Existing Class B Common Shares in exchange for certificates representing Existing Class B Common Shares. From and after the Effective Date, certificates representing shares of Existing Class B Common Shares are hereby canceled and shall represent only the right of the holders thereof to receive New Class A Shares."


