
- NETWORK COMMUNICATIONS INC., U.S. Trademark Registration No. 2,658,001; and

(the "Trademarks"), was recorded with the Assignment Branch of the United States Patent and Trademark Office on June 30, 2010 at Reel 4234, Frame 0356 (the "Security Interest").

Said Security Interest was recorded erroneously with respect to the Trademarks in that the Trademarks are owned by Network Communications, Inc., a **Nebraska** corporation, and not by Grantor and, therefore, (1) Grantor possessed no interest in either of the Trademarks to grant Grantee and (2) Grantee had no interest in either of the Trademarks to assign to its successor Collateral Agent, the undersigned Wells Fargo Capital Finance, Inc.
