RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

Without limiting the generality of the foregoing, Secured Party hereby unconditionally and expressly releases, terminates and extinguishes its lien on and security interest in the trademark described on Schedule 1 to the Intellectual Property Security Agreement, a true and correct copy of which Schedule 1 is attached hereto.


This Release shall be binding upon Secured Party's legal representatives, successors and assigns.
