GRANT OF SECURITY INTEREST

This Grant of Security Interest is made as of the 19th day of April, 2012 ("the Effective Date") by Internet Wholesaler, Inc., a Delaware corporation having as its address 660 Hermitage Circle Palm Beach Gardens FL 33410 ("Borrower") in favor of William D. Light, having as his address P.O. Box 11524 Chattanooga, TN 37401 ("Lender").

Whereas Borrower owns the U.S. Trademark registrations, unregistered marks and domain names listed on Attachment 1, as well as the goodwill associated therewith (collectively, "the Trademark Collateral");

Whereas pursuant to a security agreement between the parties made on April 19, 2012 ("Security Agreement"), Lender has agreed to make a loan to Borrower as evidenced by a promissory note ("Note") and Borrower has agreed to satisfy certain obligations, including (but not limited to) the obligation to repay all sums due under the Note ("Obligations");

Whereas pursuant to the Security Agreement, Borrower has agreed to mortgage, pledge and grant to Lender a security interest in all of Borrower's right, title and interest in the Trademark Collateral to secure the satisfaction of the Obligations by Borrower;

Therefore for and in consideration of the covenants, representations and warranties set out in the Security Agreement, and as inducement for Lender to make the loan described in the Note:

1. As collateral security for the prompt and complete performance when due of the Obligations, Borrower does hereby sell, assign and transfer to Lender, its successors, assigns and legal representatives, a security interest in all of Borrower's right, title and interest, for all countries, in and to the Trademark Collateral, including all renewals and extensions, all licenses, all goodwill, all rights to sue and recover for any and all infringements or other injuries to goodwill, and any and all proceeds of the foregoing.
2. Borrower represents and warrants to Lender that Borrower has full and complete authority to execute this Grant of Security Interest, and that as of the Effective Date, Borrower is the owner of the Trademark Collateral, and no other person or entity has any security interest or other right in the Trademark Collateral.
3. All the provisions of this Grant of Security interest shall inure to the benefit of Lender and its successors, assigns and representatives and shall be binding on Borrower and its successors, assigns, and representatives.
