ASSIGNMENT OF TRADEMARK

This Assignment of Trademark Agreement is effective as of the 20th day of March, 2012, by and between Wilson McManus, an individual ("Assignor"), and Trusty Vet Licensing, LLC, an Alabama limited liability company ("Assignee").

RECITALS:

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, said Assignor does hereby assign unto Assignee all rights, title and interest in and to the Mark and the above identified application for registration of the Mark as part of the entire business or portion thereof to which the Mark pertains as required by 15 U.S.C. § 1060, together with the goodwill of the business symbolized by the Mark, past common law causes of action;

Assignor represents and warrants that it has not conveyed any rights whatsoever to any third person or entity in and to the Mark.

The Commissioner of Patents and Trademarks is requested to make the proper notation of such assignment on the trademark records of the United States of America, as maintained at the USPTO.
