WHEREAS, Assignor further covenants and agrees that it will sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said Assignee, its successors, legal representatives and assigns, as reasonably necessary to complete and perfect the transfer of said Trademarks in all countries.

NOW, THEREFORE, for \$1.00 and other good and valuable consideration, the receipt of which is hereby acknowledged, and subject to the solely exclusive license agreement between Assignor and Assignee executed concurrently with this assignment, Assignor does hereby sell and assign unto Assignee all right, title and interest in and to the Trademarks, together with the associated goodwill of the business connected with and symbolized by the Trademarks, and all rights for recovery, damages and profits for past infringements, if any.
