AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY AGREEMENT


This Affidavit to Affirm the Release of Security Agreement is effective as of April 30, 2012 pursuant to the fulfillment of the loan obligations.

I, Neil McLachlan, do hereby declare as follows:

1. I am the President of Monaco Spinco Inc., a Delaware corporation, located at 4751 Hempstead Station Drive, Kettering, Ohio 45429.
2. Monaco Spinco Inc., acquired certain trademarks from MeadWestvaco Corporation on April 27, 2012.
3. MeadWestvaco Corporation acquired certain trademarks from The Mead Corporation on December 31, 2002.
4. The Mead Corporation (successor-in-interest to Westab, Inc., and formerly known as Western Table & Stationery Corporation) acquired certain trademarks from At-A-Glance, Inc. on November 20, 2000.
5. At-A-Glance, Inc. acquired certain trademarks from Cullman Ventures, Inc., (successor-in-interest to Success Business Industries, Inc., which is formerly known as Columbian Art Works, Inc.) on November 20, 2000.
6. Cullman Ventures, Inc. acquired certain trademarks from Sheaffer Eaton Inc. on February 11, 1988.
7. Sheaffer Eaton Inc. acquired certain trademarks from Textron Inc. on August 28, 1987.
8. Columbian Art Works, Inc. acquired certain registrations from Columbian Industries, Inc. (formerly known as Columbian Art Works, Inc.) on April 6, 1972.
9. Textron, Inc. acquired certain trademarks from Eaton Paper Corporation on January 2, 1968.
10. Certain of these predecessor entities granted the following security interests (the "Security Interests") to select lenders:
 - A Security Interest was granted to Congress Financial Corporation (Central) by Columbian Art Works, Inc. dated 7/30/1991, and was recorded on 8/1/1991 at Reel/Frame 0803/0861. Subsequently, the Security Interest was assigned from Congress Financial Corporation (Midwest) by Congress Financial Corporation (Central) dated 10/1/1993 and recorded on 12/7/1993 at Reel/Frame 1083/0497. The trademarks are listed on **Schedule I**.
 - A Security Interest was granted to National Westminster Bank USA by Sheaffer Eaton, Inc. dated 8/28/1987, and recorded on 2/9/1988 at Reel/Frame 0592/0238. The trademarks are listed on **Schedule II**.
 - A Security Interest was granted to First Union National Bank of North Carolina by Cullman Ventures, Inc. dated 2/10/1988, and recorded on 2/16/1988 at Reel/Frame 0593/0662. The trademarks are listed on **Schedule III**.
11. The obligations secured by the Security Interests have been repaid in full and the Security Interests have been terminated.
12. Due to unknown reasons, releases of the Security Interests for the above were not previously filed with the U.S. Patent and Trademark Office Assignment Division.
