**RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Release of Intellectual Property Security Agreement (this "Release") is given as of May 1, 2012, by SQUARE 1 BANK, a North Carolina corporation, having an office at 406 Blackwell Street, Suite 240, Durham, North Carolina 27701 (the "Bank") for the benefit of SMARTSYNCH, INC., a Delaware corporation, located at 4400 Old Canton Road, Jackson, Mississippi 39211 (the "Debtor");

WHEREAS, Debtor has fully discharged and satisfied the obligations secured by the Intellectual Property Security Agreement, dated as of October 1, 2009 ("Security Agreement"). The Security Agreement was recorded in the United States Patent and Trademark Office at Reel 4072/Frame 0919 against the trademarks attached hereto as Exhibit A (the "Trademark Collateral"); and


WHEREAS, Debtor has requested that the Bank release, and the Bank is willing to release, subject to the terms hereof, its security interest, and any other right, title and interest it may have in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby agrees as follows:

1. Bank does hereby terminate and release, without any recourse, representation or warranty, any and all security interests and all other right, title or interest that it may have in, to or under, the Trademark Collateral and thereby discharge the recordation of the Intellectual Property Security Agreement against the Trademark Collateral.
2. Bank agrees to take such further action as may be reasonably requested by Debtor, from time to time, at Debtor's expense, to effectuate and carry out the provision and intent of this Release.
3. Bank represents and warrants to Debtor that it has not conveyed, transferred, granted a security interest in, hypothecated or otherwise pledged or disposed of any of the rights, title or interest granted to the Trademark Collateral under the Security Agreement to any party other than Debtor.

IN WITNESS WHEREOF, the undersigned has caused this Release of Intellectual Property Security Agreement to be executed and delivered as of the date first written above.
