## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “***Termination***”), is dated as of May 1, 2012, and made by ARES CAPITAL CORPORATION, a Maryland corporation, having an office at 280 Park Avenue, 22nd Floor East, New York, New York 10017 (“***Collateral Agent***”) to JAVELIN LEARNING SYSTEMS, INC., a Georgia corporation (“***Grantor***”), located at 4501 Circle 75 Parkway, Suites D-4280 and D-4100, Atlanta, GA 30339.

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of December 23, 2009, made by Grantor in favor of Collateral Agent (the “***Security Agreement***”), a security interest was granted by the Grantor to Collateral Agent in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on December 23, 2009, on Reel 004119 at Frame 0805; and

WHEREAS, Collateral Agent now desires to release such security interest and terminate the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Collateral Agent hereby states as follows:

1. Definitions. The term “Trademarks,” as used herein, shall mean all of the Grantor’s right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto. All other initially capitalized terms used herein without definition shall have the meanings ascribed thereto in the Security Agreement.

2. Release of Security Interest. Collateral Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Collateral Agent in the Trademarks and Trademark Collateral.
