RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") is made as of April 30, 2012 ("Effective Date") between MANUFACTURERS AND TRADERS TRUST COMPANY, a New York banking corporation, with an office at One M&T Plaza, Buffalo, New York 14203 (the "Lender"), and WORLD COURIER MANAGEMENT, INC., a Delaware corporation, having an address at 125 Whipple Street, Providence, Rhode Island 02908 ("WCM")


