THIS RELEASE dated as of April 30, 2012 (this "Release") is made by Wilmington Trust, National Association (successor by merger to Wilmington Trust FSB), acting in its capacity as collateral trustee (together with any successor(s) thereto in such capacity, the "Collateral Trustee") for each of the Secured Parties (as defined in the Trademark Security Agreement referenced below) under that certain Trademark Security Agreement, dated as of November 24, 2009, and recorded in the records of the United States Patent and Trademark Office, at Reel 4118/Frame 0756 (as amended, supplemented or modified and in effect prior to the date hereof, the "Trademark Security Agreement"), among Viasystems, Inc., a Delaware corporation, Viasystems Technologies Corp., L.L.C., a Delaware limited liability company (collectively, the "Grantors"), and the Collateral Trustee;

W I T N E S S E T H:

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office, the Grantors granted to the Collateral Trustee a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) including those set forth on Schedule I attached hereto;

WHEREAS, the Collateral Trustee wishes to: (i) terminate the Trademark Security Agreement against the Trademark Collateral including those identified in Schedule I attached hereto, recorded with the United States Patent and Trademark Office; (ii) release all of its security interest in the Trademark Collateral including those listed in Schedule I attached hereto; (iii) restore all right, title and interest in and to the Trademark Collateral including those listed in Schedule I attached hereto, to Grantors; and (iv) to dissolve any and all liens and encumbrances


granted to it by Grantors respecting the Trademark Collateral including those listed in Schedule I attached hereto.
