ASSIGNOR does hereby sell, assign, and transfer to ASSIGNEE all of ASSIGNOR'S right, title and interest in and to the Trademarks, including the corresponding United States registrations owned by ASSIGNOR for such Trademarks, all common law rights, any foreign rights that ASSINGEE may possess related to the Trademarks, including all words and/or designs comprising the Trademarks, and that part of the business of ASSIGNOR connected with the use of and symbolized by said Trademarks, including the subject matter of any and all claims that may be obtained in every such Trademark and all rights to sue and to recover thereon, including without limitation all claims and causes of action for, and all rights to sue and recover and retain damages and profits for, past infringement of any such Trademarks by any party, the same to be held and enjoyed by ASSIGNEE, its successors, assignees, and other legal representatives as fully and entirely as the same would have been held and enjoyed by ASSIGNOR has this Trademark Assignment not been executed.

2. This Trademark Assignment shall be governed and interpreted according to the laws of the State of New York without recourse to conflicts of laws principles.




