DEED OF ASSIGNMENT OF TRADEMARKS

AGREEMENT made as of January 18, 2012 between Delos Living, LLC, a Delaware limited liability company with principal address located at 54 Thompson Street, 4<sup>th</sup> Floor, New York, NY 10018 ("Assignor") and Vestis New York LLC, a New York limited liability company with principal address located at 54 Thompson Street, 4<sup>th</sup> Floor, New York, NY 10018 ("Assignee").

For good and valuable consideration, the receipt of which is hereby acknowledged, it is agreed as follows:

1. Assignment of the 4.4, 4POINT4, 4.4 MILLION DAYS and FOURPOINTFOUR Trademarks. Assignor is the sole owner of all right, title and interest in and to the United States the following trademarks: (i) 4.4, U.S. Trademark Serial No. 85-340,465; (ii) 4POINT4, U.S. Trademark Serial No. 85-340,471; (iii) 4.4 MILLION DAYS, U.S. Trademark Serial No. 85-340,476; and (iv) FOURPOINTFOUR, U.S. Trademark Serial No. 85-340,481. Assignor hereby assigns, conveys, transfers and quitclaims unto Assignee all of Assignor's right, title and interest, and all attendant good will, in and to those four trademarks.

2. General Provisions. This Agreement shall be binding upon and inure to the benefit of each of the parties hereto, and their respective successors and assigns, except that neither party shall assign any of its rights or obligations hereunder without the prior consent of the other party. No amendment or subsequent addition to this Agreement, and no representations, agreement, consent, permission, acceptances or grant or modification of any right or obligation in connection herewith shall be effective unless made in a writing duly executed by all of the parties. No oral agreement or representation subsequently made, by the parties, whether or not relied or acted upon, and no usage of trade, whether or not relied or acted upon, shall amend this Agreement or impair or otherwise affect any party's obligations pursuant to this Agreement. This Agreement shall be governed by, and interpreted and construed in accordance with, the laws of the State of New York, and where applicable, of the United States, without regard to principles of conflict of laws. This Agreement may be executed in counterparts, each of which shall be deemed an original and all of which shall constitute one and the same instrument.
