## TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Gardner Asphalt Corporation ("Assignor"), a Delaware corporation whose address is 4161 E. 7<sup>th</sup> Avenue, Tampa, Florida 33605, has adopted and is using the trademarks set forth in Exhibit A attached to this agreement (the "Marks").

WHEREAS, Sun Coatings Inc. ("Assignee"), a Florida corporation whose address is 4701 E 7<sup>th</sup> Ave, Tampa, Florida 33605, wishes to acquire sole rights in and ownership to the Marks, together with the goodwill of the business in connection with which the Marks have been used (the "Goodwill").

WHEREAS, Assignor desires to assign any and all rights it may have in the Marks, together with the associated Goodwill, to Assignee, and Assignee desires to acquire said rights from Assignor.

NOW, THEREFORE, Assignor and Assignee hereby agree as follows:

### TERMS AND CONDITIONS

Section 1 – Assignment. In return for good and valuable considerations provided by Assignee to Assignor, the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee and its successors and assigns Assignor's entire right, title, and interest in and to the Marks and the Goodwill, to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its subsidiaries, licensees, successors, assigns, and legal representatives, for the full extent of the life of the Marks, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made, including without limitation all applications and registrations for such Marks.

Section 2 – Defense of Rights. Assignor further grants to Assignee the right to sue for past infringement, dilution, and any other violation of rights in the Marks and the Goodwill. The expense of such suits to protect the rights in the Marks and the Goodwill shall be borne entirely by Assignee, and any and all recoveries from any suit or settlement shall go to Assignee.


Section 3 – Warranty. Assignor represents and warrants that he has full power to make this Assignment, and that Assignor has not and will not execute any agreement in conflict herewith.

Section 4 – Integration. This Agreement contains the entire understanding of the parties, and supersedes previous verbal and written agreements or representations between the parties concerning the Marks.

IN WITNESS WHEREOF, Gardner Asphalt Corporation and Sun Coatings Inc. have caused this Assignment to be executed, to be effective as of May 4, 2012.


