INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT, dated as of March 21, 2012 (this "Assignment"), which shall be effective as of the date hereof at 12:00 a.m., is made and entered into by and among Real Mex Restaurants, Inc., a Delaware corporation (the "Company"), the Subsidiaries of the Company listed on the signature pages hereto (together with the Company, the "Sellers") and the following Delaware limited liability companies: RM Chevys LLC ("Chevys"), RM Acapulco LLC ("Acapulco"), RM El Torito LLC ("El Torito") and RM Foods LLC ("RM Foods" and collectively with Chevys, Acapulco and El Torito, the "Assignees"). The Sellers and Assignees are sometimes herein referred to collectively as the "Parties" and individually as a "Party."

WHEREAS, the Sellers and RM Opco LLC ("Purchaser") entered into that certain Asset Purchase Agreement dated as of February 10, 2012 (the "Asset Purchase Agreement"); and

WHEREAS, Purchaser assigned its rights under the Asset Purchase Agreement to the Assignees.

NOW, THEREFORE, in consideration of the covenants and agreements contained herein and in the Asset Purchase Agreement, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the parties agree as follows:

1. Assignment. The Sellers hereby convey, assign, transfer and deliver to Assignees all of such Sellers' right, title and interest in and to the Purchased Intellectual Property, including, without limitation, all Marks and domain names listed on Schedules A, B, C and D attached hereto, to the Assignees set forth on Schedules A, B, C and D, together with all goodwill and other intangible assets associated therewith and with the business or the portion of the business to which the Marks pertain. For the avoidance of doubt, the Sellers are not conveying, assigning, transferring or delivering to the Assignees any of the Excluded Assets.

2. Acceptance and Assumption. The Assignees hereby accept the conveyance, assignment, transfer and delivery of the Purchased Intellectual Property, including, without limitation, all Marks and domain names listed on Schedules A, B, C and D attached hereto, together with all goodwill and other intangible assets associated therewith.

3. Further Assurances. The Sellers and Assignees shall, at the applicable Assignee's expense, execute and deliver, or cause to be executed and delivered, from time to time hereafter, upon request and without further consideration, all such further documents and instruments and shall do and perform all such acts as may be reasonably necessary to give full effect to the intent of this Assignment.

4. Effectiveness. This Assignment shall be effective as of the Closing.

5. Terms of the Asset Purchase Agreement. Capitalized terms used but not defined herein shall have the meanings given to such terms in the Asset Purchase Agreement. This Assignment is in accordance with and is subject to all of the terms and conditions of the Asset Purchase Agreement. Nothing contained in this Assignment shall be deemed to supersede,

Assignee contained in the Asset Purchase Agreement. In the event of any conflict or inconsistency between this Assignment and the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall prevail.

6. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware applicable to contracts made and performed in such State.

7. Successors and Assigns. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns. Nothing in this Assignment shall create or be deemed to create any third party beneficiary rights in any Person or entity not a Party.

8. Counterparts. This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same agreement.


