ASSIGNMENT

These rights are assigned together with all claims by ASSIGNOR for damages by reason of past infringement of the MARKS, with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors and assigns.

2. ASSIGNOR will, by its officers, employees, legal representatives or other persons duly authorized, communicate to ASSIGNEE, or the representatives thereof, any facts known to ASSIGNOR respecting the MARKS, and will, upon request, testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by the ASSIGNEE or by counsel

for ASSIGNEE, to assist or enable the ASSIGNEE to obtain and enforce full benefits from the rights and interests herein assigned. ASSIGNOR additionally agrees to execute copies of this assignment or portions thereof regarding any or all of the aforementioned MARKS, as required by ASSIGNEE in the future.

3. ASSIGNOR hereby agrees to waive all rights and privileges to attack any of the MARKS or the registration of any or all of the MARKS. ASSIGNOR abandons any other applications or claims to the MARKS, assigning to ASSIGNEE all rights, title and interest of any nature.

4. ASSIGNOR will not adopt and/or use any mark which is a colorable imitation that is likely to cause confusion with any of the MARKS.
