## RELEASE OF TRADEMARK SECURITY AGREEMENT

**THIS RELEASE OF TRADEMARK SECURITY AGREEMENT**, dated as of April 18, 2012 (the "Release") is from **GENERAL ELECTRIC CAPITAL CORPORATION**, as Administrative Agent and Collateral Agent for the Lenders (the "GE Capital") in favor of **PARLUX LTD.** and **PARLUX FRAGRANCES, INC.** (collectively, the "Companies").

### WITNESSETH

WHEREAS, the Companies and GE Capital have heretofore entered into that certain Credit Agreement, dated as of June 25, 2010 (as amended, the "Credit Agreement"), by and among GE Capital, the Companies and the lenders party thereto (the "Lenders") (capitalized terms used herein and not defined herein shall have the meanings given such terms in the Credit Agreement);

WHEREAS, pursuant to the Credit Agreement, the Companies and GE Capital have heretofore entered into that certain Trademark Security Agreement, dated as of June 25, 2010 (the "Trademark Security Agreement"), recorded on June 28, 2010 as Reel/ Frame No. 4232/0915, in the U.S. Patent and Trademark Office;

WHEREAS, the Companies granted a lien and a security interest to GE Capital for the benefit of the Secured Parties, in all of their right, title and interest in, to and under the Trademark Collateral described in the Trademark Security Agreement, including, without limitation, the trademarks particularly described in Exhibit "A" attached hereto (collectively, the "Trademark Collateral");


WHEREAS, GE Capital has consented to the release of its lien on the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, GE Capital hereby covenants and agrees that its lien on the Trademark Collateral is hereby terminated and released..
