**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF
COMPASS BANCSHARES, INC.**

Pursuant to the provisions of Section 10A-2-10.06 of the Alabama Business Corporation Law, the undersigned Corporation (the "Corporation") hereby adopts the following Articles of Amendment to Articles of Incorporation.

ARTICLE I

The name of the Corporation is Compass Bancshares, Inc.

ARTICLE II

The following amendment was adopted in the manner provided for in the Alabama Business Corporation Laws. Article I of the Articles of Incorporation shall be amended by deleting Article I in its entirety and substituting in lieu thereof the following:

"ARTICLE I
Name

The Name of this corporation (the "Corporation") shall be:

BBVA Compass Bancshares, Inc."

ARTICLE III

The amendment was adopted by the shareholders and directors of the Corporation in the manner prescribed by law on May 26, 2011.

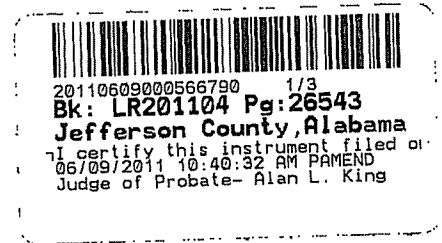
ARTICLE IV
