
Trademark Ownership Agreement

This document shall serve to memorialize the joint ownership of the trademark "Driving Force" in classification 25, 22 and 39, for technical gloves, shoes and accessories for auto and motorcycle racing as registered with the United States Patent and Trademark Office (USPTO). It is hereby acknowledged that Roman Kuzma and Paet Hidalgo, the "parties", each own an equal 50% percent interest in the mark Driving Force (USPTO Registration Number 2,422,517), along with its goodwill.

Should either party decide to sell their interest in the mark prior to expiry, the other shall have first right of refusal to purchase the entire interest of the other party, or should the parties agree to sell their equal interest to a third party in whole or part, the parties agree that proceeds from such sale shall be divided equally between the parties, with any applicable tax liability to be assigned to the parties individually and separately.


