TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 10, 2012 by **FREEPORT FINANCIAL LLC** (“**Freeport**”) in favor of **HOMAX PRODUCTS, INC.**, a Delaware corporation, **BIX ENTERPRISES, INC.**, a Delaware corporation, **THE GONZO CORPORATION**, a Massachusetts corporation, **JASCO CHEMICAL CORP.**, a California corporation, **MAGIC AMERICAN PRODUCTS, INC.**, a Delaware corporation, **OSMEGEN INCORPORATED**, a Pennsylvania corporation, **RHODES AMERICAN PRODUCTS, INC.**, a Delaware corporation, **STONE CARE INTERNATIONAL, INC.**, a Maryland corporation and **SITE-B COMPANY**, a Washington corporation (collectively, the “**Grantors**” and each a “**Grantor**”).

W I T N E S S E T H:

WHEREAS, Freeport and the Grantors are parties to that certain Trademark Security Agreement dated as of November 2, 2006 (the “**Assignment**”), pursuant to which each Grantor granted a security interest to Freeport in the Trademark Collateral (as defined in the Assignment), including, without limitation, the Trademarks set forth on Schedule 1 hereto (collectively, the “**Secured Trademarks**”), as security for certain obligations owing by Grantors to Freeport; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on November 7, 2006, at Reel 3423; Frame 0172; and

WHEREAS, Grantors have requested that Freeport release its security interest in the Secured Trademarks and reassign the same to Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Freeport hereby releases its security interest in all of each Grantor’s right, title and interest in and to the following Secured Trademarks, including, without limitation,:

(i) each trademark and application for trademark listed on Schedule I annexed hereto, together with any reissues, continuations or extensions thereof;

(ii) all goodwill of the business connected with the use of, and symbolized by, each such trademark; and

(iii) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past,

present and future infringement, misappropriation, dilution, violation or other impairment thereof

2. Freeport hereby reassigns, grants and conveys to each Grantor, without any representation, recourse or undertaking by Freeport, all of Freeport's right, title and interest in and to the Secured Trademarks.


3. Freeport agrees, at the Grantors' expense, to cooperate with the Grantors and to provide the Grantors with the information and additional authorization reasonably requested by any Grantor to affect the release of the Freeport's security interest in and lien on the Secured Trademarks.

4. This Trademark Release and Reassignment and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of Illinois.
