WHEREAS, Assignor has adopted and used the trademarks listed in the Schedule set forth herein (the "Trademarks");


WHEREAS, Assignor has obtained United States trademarks registrations for the Trademarks listed in the Schedule set forth herein (the "Registrations"); and




