TRADEMARK GRANT OF SECURITY INTEREST

WHEREAS, Fab-Tech, Inc., a corporation formed under the laws of Vermont, with a principal place of business at 480 Hercules Drive, Colchester, VT 05446 (the "Grantor"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Grantor and two other affiliated companies, Composite & Metal Products USA, Inc. and Sequel Industrial Products, Inc.. (collectively with Grantor, the "Companies"), have entered into (i) a certain Senior Revolving Credit, Term Loan and Security Agreement, dated May 10, 2012, among **RBS Citizens, N.A.** ("Senior Lender") and the Companies and (ii) a certain Trademark Collateral Security Agreement, dated May 10, 2012, made by Grantor in favor of Senior Lender (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Grantor is granting to Senior Lender for its benefit a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor;


NOW, THEREFORE, for good and valuable consideration and the financial accommodations provided Companies by Senior Lender, the receipt of which is hereby acknowledged, Grantor hereby grants to Senior Lender for its benefit a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which security interest shall secure all the Obligations (as defined in the Agreements) in accordance with the terms and provisions of the Agreements; provided that notwithstanding anything to the contrary contained herein, the security interest granted herein shall not constitute a grant of a security interest in the Excluded Assets (as defined in the Agreements).
