

**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of May 14, 2012 (this "Release"), is made by BARCLAYS BANK PLC, in its capacity as the Collateral Agent for the Secured Parties (the "Collateral Agent"), in favor of the Grantors (as defined below), pursuant to the termination of the Credit Agreement, dated as of December 22, 2010, by and among HARBOR FREIGHT TOOLS USA, INC., a Delaware corporation (the "Borrower"), HFT HOLDINGS, INC., a Delaware corporation, the Collateral Agent, and the other persons party thereto (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"). Capitalized terms used herein but not otherwise defined herein have the meanings ascribed to them in the Credit Agreement or the Intellectual Property Security Agreement (as defined below), as applicable.

WITNESSETH

WHEREAS, the Borrower, the other grantors party thereto (together with the Borrower, the "Grantors") and the Collateral Agent are parties to the Pledge and Security Agreement, dated as of December 22, 2010 (as amended, supplemented or otherwise modified from time to time, the "Pledge and Security Agreement");

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantors executed the Intellectual Property Security Agreement by and among the Grantors and the Collateral Agent for the Secured Parties, dated December 22, 2010 (as amended, supplemented or otherwise modified from time to time, the "Intellectual Property Security Agreement") and recorded with the U.S. Patent and Trademark Office on December 28, 2010 at Reel/Frame Nos. 25569/0620 and 4438/0706, pursuant to which such Grantors granted to the Collateral Agent, for itself and for the ratable benefit of the Secured Parties, a security interest in and continuing lien on all of such Grantors' right, title and interest in, to and under all Patents (as defined in the Intellectual Property Security Agreement) (the "Patent Collateral"), Trademarks (as defined in the Intellectual Property Security Agreement) (the "Trademark Collateral"), Copyrights (as defined in the Intellectual Property Security Agreement) (the "Copyright Collateral") and Exclusive Copyright Licenses (as defined in the Intellectual Property Security Agreement) (the "Copyright License Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

The Collateral Agent, on its own behalf and on behalf of the Secured Parties, hereby unconditionally and irrevocably relinquishes, terminates, cancels, discharges and releases any and all right, title and interest it or they may have or have acquired through the Intellectual Property Security Agreement, or otherwise, in and to the Patent Collateral, Trademark Collateral, Copyright Collateral, Copyright License Collateral and any other Intellectual Property Collateral (as defined in the Intellectual Property Security Agreement), including the patents and patent applications, and the trademark and service mark registrations listed on Schedule I attached hereto and incorporated herein by reference, together with all proceeds (such as license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements throughout the world and reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof and goodwill associated with any of the foregoing (as applicable) (collectively, the "Released Collateral"), and hereby unconditionally and irrevocably assigns, transfers and conveys to the applicable Grantor all right, title and interest of the Collateral Agent and the Secured Parties in the Released Collateral. This Release shall be binding upon the Collateral Agent's legal representatives, successors and assigns.

The Collateral Agent authorizes the recordation of this Release with the U.S. Patent and Trademark Office and any other applicable registry, the filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Collateral Agent's Lien upon and security interest in the Patent Collateral and the Trademark Collateral by the Grantors or any person authorized or designated by the Grantors, and any such recordation or filing shall be deemed to have been authorized by the Collateral Agent.

The Intellectual Property Security Agreement is hereby terminated.

The Collateral Agent agrees to provide the Grantors with any additional authorization and to execute any other documents necessary to effect the release of its security interest in the Released Collateral, all at the expense of the Grantors.
