**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Marks set forth on Exhibit A and retransfers and reassigns to Grantor, without representation, warranty, recourse or undertaking of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest in and to the Marks set forth on Exhibit A, the goodwill associated therewith and all causes of action for past infringement, if any. For purposes of clarity, Agent's security interest in and to all other trademarks and trademark applications of Grantor as recorded with the USPTO at Reel 3827, Frame 0011 shall continue and remain in full force and effect.
