**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

This Release of Security Interest in Intellectual Property, effective as of May 15, 2012, is granted by Bank of America, N.A., a national banking association, as Administrative Agent under the OA IP Security Agreement (as defined below) (in such capacity, "Agent") and as successor to Fleet National Bank (in such capacity, "Fleet Successor"), with its principal office at 100 Federal Street, Boston, MA 02110 to On Assignment, Inc., a Delaware corporation and each of its direct and indirect Subsidiaries listed on Schedule 1 hereto (collectively, the "Grantors" and each a "Grantor"), with its principal office at 26745 Malibu Hills Road, Calabasas, CA 91301, as follows:

**WITNESSETH**

WHEREAS, the Grantors have heretofore granted to Bank of America, N.A., a national banking association, as administrative agent (the "Agent"), a security interest in certain trademark registrations, applications for trademark registrations and the goodwill associated therewith as set forth on Schedule 2 attached hereto (the "On Assignment IP") pursuant to that certain Intellectual Property Security Agreement dated as of December 3, 2010 by and among the Grantors and the Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time the "OA IP Security Agreement"), as recorded in the U.S. Patent and Trademark Office on December 9, 2010 at Reel/Frame number 4428/0940.

WHEREAS, Oxford Global Resources, Inc. (formerly known as Oxford & Associates, Inc.) ("Oxford") had heretofore granted to Fleet National Bank ("Fleet"), a security interest in that certain trademark registration, application for trademark registration and the goodwill associated therewith as set forth on Schedule 3 attached hereto (the "Fleet IP", and together with the On Assignment IP, the "Intellectual Property"), pursuant to that certain Security Agreement dated as of November 24, 1998 by and among others, Oxford and Fleet (as amended, restated, amended and restated, supplemented or otherwise modified from time to time the "Fleet IP Security Agreement"), as recorded in the U.S. Patent and Trademark Office on December 7, 1998 at Reel/Frame number 1823/0777.

WHEREAS, Fleet Successor has become successor to Fleet and its interests, including in the interests of the Fleet IP.

WHEREAS, the Agent acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the OA IP Security Agreement have been made.

WHEREAS, Fleet Successor acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Fleet IP Security Agreement have been made.

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Intellectual Property to the Grantors and to dissolve any and all liens and encumbrances respecting the Intellectual Property under the OA IP Security Agreement.

WHEREAS, Fleet Successor wishes to release and restore all right, title and interest in and to the Intellectual Property to the Grantors and to dissolve any and all liens and encumbrances respecting the Intellectual Property under the Fleet IP Security Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the applicable Grantor the security interest in the Intellectual Property set forth on Schedule 2 and Fleet Successor hereby releases, discharges, quit claims and relinquishes unto Oxford the security interest in the Intellectual Property set forth on Schedule 3.
