## INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT, dated April 3, 2012 (this "**Assignment**"), is entered into by and between F3 BRANDS LLC, a Delaware limited liability company ("**F3 Brands**"), BLITZ U.S.A., INC., an Oklahoma corporation ("**Parent**"), BLITZ RE HOLDINGS, LLC, a Delaware limited liability company ("**Blitz RE**" and together with F3 Brands and Parent, the "**Assignors**" and each sometimes referred to as a "**Assignor**"), and HOPKINS MANUFACTURING CORPORATION, a Kansas corporation ("**Assignee**"). Both Assignor and Assignee are collectively referred to herein as the "**Parties**."

**WHEREAS**, Assignor and Assignee have entered into an Asset Purchase Agreement dated March 28, 2012, (the "**Agreement**");

**WHEREAS**, pursuant to the Agreement, Assignor agreed to assign to Assignee its right, title and interest to the Purchased Intellectual Property (as defined in the Agreement), which includes, without limitation, the intellectual property listed on Schedule A attached hereto (collectively, the "**Assigned Intellectual Property**"); and

**WHEREAS**, Assignor wishes to confirm Assignee's ownership of the Assigned Intellectual Property and assign to Assignee any right, title and interest that Assignor may have in and to the Assigned Intellectual Property:

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby sells, transfers, conveys, assigns and delivers to Assignee any and all worldwide right, title and interest Assignor holds, or may hold, in and to:
  - a. the Assigned Intellectual Property (including, without limitation, (i) all of Assignor's trademarks, service marks, trade names, service names, brand names, trade dress rights, logos, design rights, Internet domain names and corporate names and general intangibles of a like nature, together with the goodwill associated with any of the foregoing, and all applications, registrations and renewals thereof in the United States and anywhere in the world that are included in such Assigned Intellectual Property (collectively, the "**Marks**"), and (ii) all of Assignor's issued patents and applications therefor, including continuations, divisionals, continuations-in-part, or reissues of patent applications and patents issuing thereon, that are included in such Assigned Intellectual Property (collectively, the "**Patents**"), and
  - b. the following properties and rights with respect to the Assigned Intellectual Property, as applicable:
    - i. all goodwill associated with the business related to the Marks, , together with all rights to use, license and otherwise exploit the Marks;

- ii. the business of the applicant, or portion thereof, to which the Marks pertain;
- iii. all foreign Marks that may claim priority based on and correspond to the Marks;
- iv. the inventions claimed or described in the Patents;
- v. all divisions, renewals, reissues, continuations, extensions and continuations-in-part of the Patents;
- vi. all income, royalties, damages and payments hereafter due or payable to Assignee with respect to the Assigned Intellectual Property, including, without limitation, all rights to sue and claim in and under all causes of action (whether in law or in equity), and the right to sue, counterclaim, and recover for past, present and future infringement, dilution or misappropriation of the rights assigned under this Assignment;
- vii. all rights to fully and entirely replace the Assignor in all related matters and rights of priority and protection of interest there under the laws of any jurisdiction; and
- viii. all rights in and under the Assigned Intellectual Property to the fullest extent allowed by law, including statutory, common law and contractual rights, in, to and under the Assigned Intellectual Property as fully as the Assignor would have held the same in the absence of the assignment contemplated hereby,

the same to be used and enjoyed by Assignee for its own use and enjoyment and the use and enjoyment of its successors and assigns to the end of the term or terms for which the Assigned Intellectual Property are granted or reissued or extended as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.


2. As of the date set forth above, the Assignee has succeeded to all right, title and standing of the Assignor to (a) receive all rights and benefits pertaining to the rights described above and (b) commence, prosecute, defend and settle all claims and take all actions that the Assignee, in its sole discretion, may elect in relation to the rights described above.
3. Assignor hereby covenants that Assignor shall, at the cost and expense of Assignee, take all actions and execute all documents necessary or desirable to perfect the interest of Assignee in and to the Patents, and shall not enter into any agreement in conflict with this Assignment. Upon reasonable request by Assignee, and at Assignor's sole cost and expense, Assignor will execute additional documents and take other actions as may be necessary or desirable to record or memorialize the assignments of the Patents set forth herein, and to vest in Assignee such right, title, and interest in and to the Patents as sold, assigned and transferred to Assignee hereunder.
4. This Assignment is, in all events, subject to the Agreement.
5. All capitalized terms not otherwise defined in this Assignment, as used in this Assignment, will have the respective meanings set forth in the Agreement.

6. The Parties hereby request and authorize the relevant authority at the United States Patent and Trademark Office, Canadian Intellectual Property Office, Japan Patent Office, Mexican Institute of Industrial Property and/or the applicable foreign authorities to record Assignee as the assignee and owner of the Assigned Intellectual Property.
7. This Assignment is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns. This Assignment and the rights and obligations of the Parties hereunder shall be governed by, and construed in accordance with the laws of the State of Delaware.




