RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (this "**Release**") is made as of March 31, 2010, by CITICORP TRUSTEE COMPANY LIMITED, as Security Agent (the "**Security Agent**").

WITNESSETH:

WHEREAS, Kettle Foods, Inc. (the "**Grantor**") and the Security Agent are parties to that certain Security Agreement, dated September 8, 2006 (the "**Security Agreement**");

WHEREAS, pursuant to the Security Agreement, the Grantor executed that certain Intellectual Property Security Agreement, dated October 23, 2006, in favor of the Security Agent (the "**IP Security Agreement**"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the IP Security Agreement);

WHEREAS, pursuant to the IP Security Agreement, the Grantor granted to the Security Agent a security interest in all of the Grantor's right, title and interest in and to the following (the "**IP Collateral**");

(a) the patents and patent applications set forth in Schedule A hereto (the "**Patents**");

(b) the trademark and service mark registrations and applications set forth in Schedule B hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby (the "**Trademarks**");

(c) all copyrights, whether registered or unregistered, now owned or hereafter acquired by the Grantor, including, without limitation, the copyright registrations and applications and exclusive copyright licenses set forth in Schedule C hereto (the "**Copyrights**");

(d) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto;

(e) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(f) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the IP Collateral of or arising from any of the foregoing; and

WHEREAS, the Grantor has requested that the Security Agent release its security interest in the IP Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Grantor and the Security Agent hereby agree as follows:

1. The Security Agent hereby terminates, cancels and releases its security interest in all of the Grantor's right, title and interest in and to the IP Collateral, whether granted pursuant to the IP Security Agreement or any other agreement or document delivered in connection with the Security Agreement, and the Security Agent reassigns any and all such right, title and interest (if any) that the Security Agent may have in the IP Collateral to the Grantor.


2. The Security Agent hereby agrees, at the expense of the Grantor, to take any reasonable actions and to execute any further documents necessary or reasonably requested by the Grantor to effectuate, record or evidence the release of the Security Agent's security interest in the IP Collateral.

3. This Release shall be governed by the law of the State of New York.


