TERMINATION OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

May 16, 2012

WHEREAS, PRIVATE QUARTERS, INC. (the "Grantor") had granted to WORKING CAPITAL SOLUTIONS INC. (the "Lender"), a continuing security interest (the "Security Interest") in (i) all of the Grantor's right, title and interest in, to and under to the United States trademarks, service marks, trademark registrations, service mark registrations, trademark applications and service mark applications (the foregoing, collectively, the "Marks") set forth on Schedule A attached hereto, (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (the foregoing, collectively, the "Collateral"), pursuant to, among other things, a certain Grant of Security Interest in United States Trademarks dated as of July 30, 2010 (the "Agreement"; capitalized terms used herein but not otherwise defined herein shall have the meanings assigned to such terms in the Agreement), which was filed at the United States Patent and Trademark Office on September 10, 2010 and recorded on Reel 4276, Frame 0480; and

WHEREAS, the Grantor has made payment in full of the indebtedness secured by the Security Interest in exchange for the termination of the Security Interest.

NOW, THEREFORE, the Lender releases and discharges its security interest in, and reassigns to the Grantor, any and all interest in the Collateral, including, without limitation, the Marks set forth on Schedule A attached hereto, and the goodwill of the businesses with which the Marks are associated. The Lender agrees that, upon request of the Grantor or any successor-in-interest or assignee thereof, and at the Grantor's sole cost and expense, the Lender will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantor, or any successor-in-interest or assignee thereof, to effectuate the release of interests contemplated herein.

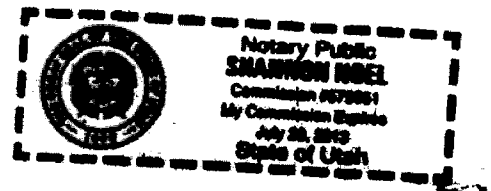
