



**DECLARATION OF PATRICK J. BOUSHKA**

I, the undersigned Patrick J. Boushka, declare under penalty of perjury pursuant to 15 U.S.C. § 1746 as follows:

1. I am employed as President of GP Cellulose, LLC and I am also a director of GP Cellulose GmbH and have personal knowledge of the facts set forth herein. In 2004 I was an officer of Koch Cellulose, LLC and was involved in the transaction described herein.

2. On February 26, 2004, Georgia-Pacific Corporation entered into an Asset and Stock Purchase Agreement (the "Purchase Agreement") with Koch Cellulose, LLC, a Delaware limited liability company ("Koch Cellulose Delaware"), to sell to Koch Cellulose Delaware certain tangible and intangible assets of its cellulose fiber business, including certain trademarks and patents used in connection with that business.

3. Prior to the closing of the said acquisition, and as permitted by the Purchase Agreement, Koch Cellulose Delaware transferred its rights to acquire the intangible assets of the business, including the patents and trademarks, to an affiliated company, Koch Cellulose GmbH, a Swiss limited liability company based in Zug, Switzerland ("Koch Cellulose Zug"). Pursuant to a Contribution and Assumption Agreement dated May 7, 2004, the rights to acquire such intangible assets were transferred to Koch Cellulose Zug.

4. At the time of the closing of the acquisition of the cellulose fiber business on May 7, 2004, Koch Cellulose Zug supplied the consideration for the acquisition of the intangible assets including the patents and trademarks, and it was the intention of all of the

parties for the assignee of the trademarks and patents of the said cellulose fiber business to be Koch Cellulose Zug. That entity should have been identified as the assignee in the individual documents prepared for recordal in each of the various Patent and Trademark Offices where the intangible assets were registered around the world, including the U.S. Patent and Trademark Office.

5. Through an inadvertent error, the assignment documents prepared for recordation of the trademark and patent assignments mistakenly showed the name of the assignee as “Koch Cellulose, LLC”, which was the name of the Delaware company, rather than “Koch Cellulose GmbH”, the Swiss company, which was the actual purchaser of those assets. The erroneous trademark and patent assignment documents were recorded in the U.S. Patent and Trademark Office at Reel 2912, Frame 0516, and Reel 015377, Frame 0860 respectively.

6. Notwithstanding the mistaken assignment documents, from the date of conveyance of the trademarks and patents in 2004 to the present time, the parties have all recognized the trademarks and patents as the exclusive property of Koch Cellulose Zug and treated Koch Cellulose Zug as the actual and beneficial owner of such assets. At all times since the acquisition of the trademarks and patents in 2004, Koch Cellulose Zug (which subsequently changed its name to “GP Cellulose GmbH”), has exercised full and complete control over the use, exploitation, licensing and management of the acquired intangible property including the patents and trademarks and Koch Cellulose Delaware has never exercised any such control with respect to those assets.

7. As evidenced by the certificates annexed as Exhibits hereto, on December 29, 2006, Georgia Pacific Corporation was converted to a Delaware corporation

(Exhibit A) and on December 31, 2006 became a Delaware limited liability company and changed its name to Georgia-Pacific LLC (Exhibit B). On January 4, 2006 the Delaware company Koch Cellulose, LLC changed its name to "GP Cellulose, LLC" (Exhibit C) and on March 17, 2006, the Swiss company Koch Cellulose GmbH changed its name to GP Cellulose GmbH (Exhibit D).

8. The parties desire to correct the inadvertent error in the name of the Assignee as shown on the previous recorded Assignment, by recording the attached Corrective Assignments in place of the erroneous documents previously recorded at Reel 2912, Frame 0516, and Reel 015377, Frame 0860, in the U.S. Patent and Trademark Office.

WHEREAS, pursuant to that certain Asset and Stock Purchase Agreement, dated as of February 26, 2004, by and among Assignee, Assignor, Leaf River Forest Products, Inc., a Delaware corporation, LRC Timber, Inc., a Delaware corporation, Old Augusta Railroad Company, a Mississippi corporation, Georgia-Pacific Asia (Hong Kong), Ltd., a Hong Kong private limited company, and Georgia-Pacific GmbH, a Swiss limited liability company ("Purchase Agreement"), Assignor has agreed to assign to Assignee the Marks (as defined below) and to execute this Trademark Assignment at the Closing (as defined in the Purchase Agreement).

NOW, THEREFORE, in consideration of the foregoing and mutual promises and covenants made herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

### 1. Definitions.

"Marks" means the trademarks, service marks and logos, in word mark, stylized and/or design formats, that are the subject of the registrations and pending applications set forth in Schedule A attached hereto.

### 2. Assignment.

Assignor hereby assigns, sells, transfers and conveys to Assignee all of its rights, title and interest throughout the world in and to the Marks and all registrations and applications issued or pending for the Marks, together with the goodwill of the business symbolized by the Marks and all rights, claims and privileges pertaining to the Marks, including, without limitation, the right to maintain and prosecute such registrations and applications for the Marks and the right to sue and recover damages for past, present and future infringement of the Marks. The Assignee hereby confirms acceptance of the assignment, sale, transfer and conveyance as aforesaid.

### 3. Further Actions.

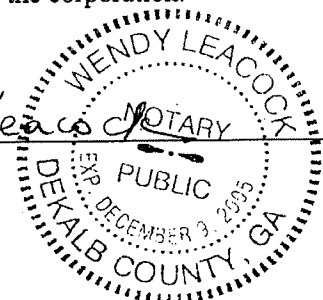
