## NOTICE OF SECURITY INTEREST

WHEREAS, Borrowers own certain rights, title and interest in and to certain assets, including but not limited to the assets listed Schedule A attached hereto;





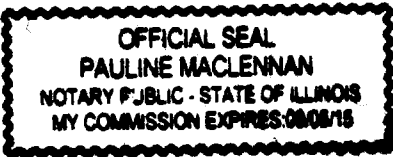
