2.	PZ Cussons Beauty LLP (Registered number 0C364213) of 14 Upper St Martin's Lane, Covent Garden, London WC2H 9FB, United Kingdom (Assignee)
Recitals	
A	The Assignor is the registered owner of the registered trade marks, designs and patents listed in the Appendix (Registrations).
B	The Assignor is the applicant seeking registration of the pending trade mark, design and patent applications listed in the Appendix (Applications).
C	The Assignor has agreed to assign to the Assignee its entire right, title and interest in and to the Applications and the Registrations, on the terms and conditions contained in this Deed.

It is agreed as follows.

1. Assignment

The Assignor assigns to the Assignee all its right, title and interest in and to the Applications (including any registrations arising in relation to the Applications) and the Registrations including:

- (a) the right to prosecute and obtain registration of the Applications;
- (b) the right to change the address for service for the Applications and the Registrations; and
- (c) all its right to institute and maintain proceedings for, and recover damages in respect of, infringement against any person who before, on or after the date of this Deed infringes rights given by the Registrations or by any registration arising in relation to the Applications.

2. Forms and proceedings

The Assignor must at the request and expense of the Assignee:

- (a) execute all documents, forms and authorisations and depose to or swear any declaration or oath as may be reasonably required for absolutely vesting all its right, title and interest in and to the Applications and the Registrations in the Assignee;
- (b) execute all documents, forms and authorisations and depose to or swear any declaration or oath as may be reasonably required for procuring the registration of the Applications; and
- (c) render the Assignee such reasonable assistance as may be reasonably necessary in any proceedings, challenge or threatened action involving any of the Registrations or the Applications (or any registrations arising from the Applications).

3. General

3.1 Governing law and jurisdiction

This Deed is governed by the laws of Victoria, Australia. Each party submits to the jurisdiction of courts exercising jurisdiction there, and waives any right to claim that those courts are an inconvenient forum.

3.2 Enurement

The provisions of this Deed will enure for the benefit of, and be binding on, the parties and their respective successors and permitted substitutes and assigns and (where applicable) legal personal representatives.

3.3 Amendment

No amendment or variation of this Deed is valid or binding on a party unless made in writing executed by all parties.

3.4 Counterparts

This Deed may be executed in any number of counterparts. All counterparts together will be taken to constitute one instrument.


3.5 Costs and stamp duty


