Assignment of Trade Marks & Domain Names

Date: 05 / 12 / 11

Parties:

(1) ASGI LIMITED, a British Company, of Argyle House, 29-31 Euston Rd, London, NW1 2SD (the "Assignor"):

(2) ASIO LIMITED, a British Company, of Argyle House, 29-31 Euston Rd, London, NW1 2SD (the "Assignee"):

Recitals:

(A) The Assignor is the Proprietor of Registered Domain Names, Registered Trade Marks and a Trade Mark Application set out in the attached Schedule ("the Trade Marks and Domain Names").

(B) The Assignor has agreed to assign to the Assignee its right, title and interest in the Domain Names and Trade Marks, including any goodwill of the Assignor symbolized by the Domains and Trade Marks, ("the Trade Mark Rights and Domain Name Rights") upon the terms and conditions set out below.

Operative provisions:

1 In consideration of the sum of One Pound Sterling (£1.00), now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor HEREBY ASSIGNS unto the Assignee:-

(a) all its right, title and interest in and to the Trade Mark Rights and Domain Name Rights and the full and exclusive benefit thereof and all rights privileges and advantages appertaining thereto; and

(b) all patents, software copyright and other intellectual property that may derive priority from or have equivalent claims to or be based upon the Trade Mark Rights and Domain Name Rights in any country of the world (and including supplementary

protection certificates, divisions, continuations, continuations in part, reissues and extensions),

TOGETHER WITH the right to recover, and take all such proceedings as may be necessary for the recovery of, damages or other forms of relief in respect of all infringements of the Trade Mark Rights and Domain Name Rights whether taking place before or after the date of the Assignment TO HOLD the same unto the Assignee absolutely.


2. The Assignor shall execute such documents and give such assistance as the Assignee may require:-

- (a) to secure the vesting in the Assignee of all rights in the Trade Mark Rights and Domain Name Rights;
- (b) to uphold the Assignee's rights in the Trade Mark Rights and Domain Name Rights; and
- (c) to defeat any challenge to the validity of, and resolve any questions concerning, the Trade Mark Rights and Domain Name Rights.

3. The validity, construction and performance of this Assignment (including any non-contractual obligations arising out of or in connection with it) shall be governed by English law, and the Assignor and the Assignee submit to the exclusive jurisdiction of the English courts in respect of any dispute or claim arising in connection therewith (including non-contractual disputes or claims).
