TO THE ARTICLES OF INCORPORATION
OF MULTI-LINE ENTERPRISES, INC.**

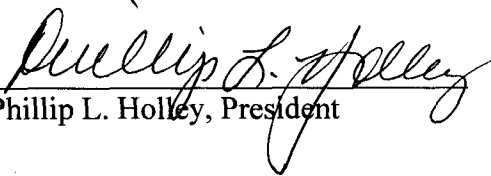
To the Secretary of State of the Commonwealth of Kentucky:

Pursuant to the provisions of the Kentucky Business Corporation Act, Mid-Line Enterprises, Inc. (the "Corporation") hereby submits these Articles of Amendment to its Articles of Incorporation:

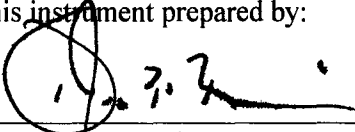
1. Article I. The name of the Corporation shall be changed to Multi Enterprises, Inc.
