Dear Ms. Jaqua:

As you know, Recognizer Industries, Inc. presently holds all right, title and interest under the _____ Promissory Note executed by Jaqua Girls, Inc. dated March 22, 2006, as well as all rights under the Business Loan Agreement and the Commercial Security Agreement given to secure the note.

The collateral under the Security Agreement covers all the inventory, accounts, equipment and general intangibles of the Corporation. These categories include all records and data (whether in the form of writing, microfiche or electronic media), along with the customer lists and computer software required to utilize, maintain and process such data, as well as all other personal and intellectual property rights, products, product formulations, and all trade names and trademarks owned by Jaqua Girls, Inc.

The Security Agreement also provides the Corporation and its guarantors will assemble and deliver the collateral and all documents relating to the collateral.

As a part of this proposal, Jaqua Girls, Inc. agrees to cooperate, without restriction, in executing and delivering all documents requested, necessary or desirable to carry out and confirm such transfers. In event of a failure to do so, Jaqua Girls, Inc. and its undersigned representative shall jointly and severally hold harmless and indemnify Recognizer Industries, Inc. from any expenses and losses, including attorneys and lost profits, incurred by Recognizer Industries, Inc. as a consequence of such failure.
