**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of May 18, 2012 ("Release"), is made by Wells Fargo Bank, National Association, as successor in interest to Wachovia Bank, National Association, as Administrative Agent (and formerly as Collateral Agent) (the "Administrative Agent") in favor of MetoKote Corporation, a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Amended and Restated Security Agreement dated as of May 27, 2005 and its predecessors (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Obligors party thereto and the Administrative Agent, each Obligor granted to the Administrative Agent, for the ratable benefit of the Lenders, a continuing security interest in, and a right to set off against, any and all right, title and interest of such Obligor in, to, and under all the Patents, Patent Licenses, and Proceeds of the foregoing; and

WHEREAS, pursuant to the Security Agreement, Grantor, an Obligor, executed and delivered to Administrative Agent, for the ratable benefit of the Lenders, the Notice of Grant of Security Interest in Patents dated as of May 27, 2005 recorded at the United States Patent and Trademark Office ("USPTO") on June 20, 2005 at Reel 016164 Frame 0388, the Notice of Grant of Security Interest in Patents dated as of May 27, 2005 recorded at the USPTO on April 7, 2004 at Reel 014499 Frame 0628, and the Notice of Grant of Security Interest in Patents dated as of May 27, 2005 recorded at the USPTO on September 19, 2002 at Reel 013305 Frame 0060 (collectively, the "Notices").

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the Lenders, and Grantor (the "parties") agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notices.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Patents, Patent Licenses, and Proceeds of the foregoing, including the foregoing listed on Schedule A attached hereto; and

(b) authorizes the recordation of this Release with the USPTO.

IN WITNESS WHEREOF, the Administrative Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
