RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") dated February 22, 2012 is made by COLE TAYLOR BANK, an Illinois banking corporation (the "Lender"), party to a Credit and Security Agreement, dated as of November 30, 2011 (the "Credit Agreement"), with (i) HB&G HOLDINGS, INC., a Delaware corporation ("HB&G Parent Company"); (ii) HB&G BUILDING PRODUCTS, INC., a Delaware corporation ("HB&G"); (iii) IMAGE ROTOMOLDING ENTERPRISES, INC., a Delaware corporation ("Image"); (iv) TURNKEY MILLWORK, INC., a North Carolina corporation ("Turnkey"); (v) FLEX TRIM HOLDING CO., a Delaware corporation ("Flex"); and (vi) DP ALABAMA HOLDING CO., INC., a Delaware corporation ("DP," and together with HB&G, Image, Turnkey, and Flex, the "Borrowers," and collectively with HB&G Parent Company, the "Obligors").

WITNESSETH:

WHEREAS, pursuant to Section 5.01 of the Credit Agreement, the Obligors each granted to the Lender a security interest in certain United States trademarks, including, but not limited to, those listed on Schedule A attached hereto (the "Flex Trim Trademarks"), to secure the Borrowers' obligations under the Credit Agreement; and


